ARTISAN AGREEMENT

Participating LinFest Artisans Receive:

- 6x6 ft booth space under a large tent with other Artisans to promote your business & sell your products
- 1 table & 2 chairs
- Signage/branding rights at booth location (self-provided)

The Participants agree to the following:

1. Only sell Artisan-made, non-perishable items and/or Artisan-prepared pre-packaged food items (no alcohol).
2. Will furnish LPNA a Certificate of Insurance naming Lindenwood Park Neighborhood Association as “additional insured” as required by the City of St. Louis. Minimum limit \$1,000,000 (contact your insurance agent to obtain). OR, sign the attached Liability Waiver if you are a home business not licensed with the City of St. Louis.
3. Will obtain the necessary inspection and permission of the St. Louis City Fire Department if any open flame and/or pressurized gas (propane) will be used.
4. Will not reassign the use of any vendor space without the prior approval of LPNA.
5. Will be responsible for collecting, reporting and paying all Federal, State and St. Louis City taxes.
6. Will not serve menu items in glass containers.
7. Will be responsible for the security of their booth area, goods and personal items.
8. LinFest has the right to photograph all vendor booths and exhibits for publicity purposes.
9. Set-Up and Take-Down: Artisans may begin Set-Up at 9am. Please use handcarts to carry additional products to your booth during the event between 11am and 4pm as vehicles will not be permitted in the park between 11am-4pm. Vehicles will be permitted on the festival grounds for Take-Down beginning at 4pm. All vehicles must be removed from the festival grounds area by 6pm.
10. Will abide by any additional requirements.

ARTISAN LIABILITY RELEASE

The undersigned agrees and does hereby release from liability and to indemnify and hold harmless LPNA, and any of its board members, committee members, employees (if any) and volunteers from any personal injuries and property loss or damage in connection with any LinFest activity. This agreement for LinFest is between the vendor and the Lindenwood Park Neighborhood Association.

By signing this Waiver and Release of Liability (Agreement), I waive and release Lindenwood Park Neighborhood Association, its agents, servants, employees, insurers, successors and assigns from any and all claims, demands, causes of action, damages or suits at law and equity of any kind, including but not limited to claims for personal injury, property damage, medical expenses, loss of services, on account of or in any way related to or growing out of my presence or involvement at the facility.

This waiver and release is intended to and does release Lindenwood Park Neighborhood Association from any and all liability for damages or injuries on account of or in any way related to or growing out of my negligence, the negligence of third parties and Lindenwood Park Neighborhood Association's negligence. This is not intended to release Lindenwood Park Neighborhood Association from any liability resulting from their intentional conduct.

I further covenant and agree not to institute any claims or legal action against Lindenwood Park Neighborhood Association for any claim released by this Agreement. I further agree that should any claim be made against Lindenwood Park Neighborhood Association in contravention of this Agreement, including but not limited to derivative claims, I will protect, defend and completely indemnify (reimburse) Lindenwood Park Neighborhood Association for any such claim and expenses including attorney's fees and costs incurred by Lindenwood Park Neighborhood Association in defending themselves or security indemnity hereunder.

2. I understand that Lindenwood Park Neighborhood Association is not responsible for any lost, stolen, or damaged valuables or property.
3. I acknowledge that I have received and read a copy of the current rules and regulations governing the use of the park. I agree that I will fully comply with all rules and regulations and with any amendments.

I have read the Agreement and understand that by signing the Agreement I have consented to be bound by its terms, including the waiver/release of any legal right I may have to sue Lindenwood Park Neighborhood Association for any costs they incur because a claim or legal action is brought in violation of this Agreement. I agree any violation of the Agreement and its terms and conditions, as determined by Lindenwood Park Neighborhood Association, will void and terminate this Agreement and may result in loss of the ability to use the facility.
